Motivation letter for the Application to become a member of the Steering Committee of EHRA

From my own experience recovery is possible. I work in the field of addictology since 2003. I started as Outreach worker. I was also working in the rapeutic community SANANIM – one year long treatment. I was working in the drop-in center SANANIM all the time. I am manager of this facility for few years now. I always found very important to incorporate humane approaches toward the work with drug users. I always found important to educate the society and try to destigmatize the community. Those are also topics I would like to focus on as member of the Steering Committee of EHRA. I am also able to share the knowledge of NGOs in Czech Republic in the addictology field, which has rich history and big evolution after the Velvet Revolution (1989). I can also provide human approach based on my experience and long term practice in direct work with drug users. I am big promoter of Harm Reduction interventions and can share the knowledge or help to incorporate such approaches in other regions. I also do lectures on this topic and can train workers.

I look at EHRA as association with similar values and beliefs as I do. I look forward to meet similar people and together work on common goals. I am applying not only as professional but as someone with deep dedication to the cause and compassion for the community.
