INDEPENDENT AUDITOR'S REPORT

To the members of Eurasian Harm Reduction Association

Opinion

We have audited the financial statements Eurasian Harm Reduction Association (the Associationy), which comprise the statement of financial position sheet at December 31, 2020, and the statement of activities for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects of the financial position of the Association as at December 31, 2020, and (of) its financial performance for the year then ended in accordance with Order 1K-372 of the Minister of Finance "On the Approval and Submission of Accounting and Financial Statements of Non-Profit Limited Liability Legal Entities and Approval of the Rules for Valuation of Assets and Services Received Free of charge by Political Campaign Participants"

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Association in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) together with the requirements of the Law on Audit of Financial Statements of the Republic of Lithuania that are relevant to audit in the Republic of Lithuania, and we have fulfilled our other ethical responsibilities in accordance with the Law on Audit of Financial Statements of the Republic of Lithuania and the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other information

The other information comprises the information included in the Association's annual report, but does not include the financial statements and our auditor's report thereon. Management is responsible for the other information.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon, except as specified below.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

In addition, our responsibility is to consider whether information included in the Association's annual report for the financial year for which the financial statements are prepared is consistent with the financial statements and whether annual report has been prepared in compliance with applicable legal requirements. Based on the work carried out in the course of audit of financial statements, in our opinion, in all material respects:

- The information given in the Association's annual report for the financial year for which the financial statements are prepared is consistent with the financial statements; and
- The Association's annual report has been prepared in accordance with the requirements of the Law on Financial Reporting by Undertakings of the Republic of Lithuania.



Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the Business Accounting Standards, and for such internal control as management determines is necessary to enable the preparation of the financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Association's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

EXPLANATORY NOTES

For the years ended 31st December 2020

I. GENERAL INFORMATION

- 1. The Eurasian Harm Reduction Association (hereinafter referred to as "the Institution") is a non-profit public legal entity. Its goal and activities are promotion of humane, evidence-based harm reduction methods in the field of drug use, reduction of prevalence of socially significant diseases, and development of policy on drug use, in order to improve health and human rights at the individual, community and social levels.
- The Institution was registered on 2nd March 2017, address Gedimino pr. 45-4, Vilnius. The Association registration number is 304470687, it is not subject to VAT. Period of operation is unlimited. The financial year of the Association is calendar year.
- 3. Number of employees at the end of 2020 year was 10.

II. ACCOUNTING POLICY

Form of financial statements

The financial statements of the Institution have been prepared in compliance with Law on Accounting and Law on Financial statements of Entities of the Republic of Lithuania, and Order No. 1K-372 of the Minister of Finance of the Republic of Lithuania On the Approval and Submission of Accounting and Financial Statements of Non-Profit Limited Liability Legal Entities and Approval of the Rules for Valuation of Assets and Services Received Free of charge by Political Campaign Participants.

The institution's accounting is carried out in accordance with the rules for the preparation and presentation of accounting and financial statements of non-profit limited liability legal entities and the valuation of assets and services received free of charge by participants in political campaigns.

The financial statements are based on the assumption that the Institution will be able to continue as a going concern in the nearest future.

Currency of the Financial Statements

The figures in these financial statements are presented in the national currency, Euro (Eur).

Non-current Intangible Assets

Intangible assets are stated at acquisition cost less accumulated amortization and impairment losses. Amortization is provided on a straight-line method (linear) with consideration of the expected useful period of intangible assets. The amortization period of intangible assets is 3 years, and the acquisition value is at least EUR 500.

Non-current Tangible Assets

Non-current assets are stated at acquisition cost less accumulated depreciation and impairment losses. Amortization is provided on a straight-line method (linear) with consideration of the expected useful period of intangible assets. Assets are classified as non-current tangible assets if their useful life is longer than one year and acquisition cost is at least EUR 500. Residual value of non-current tangible assets is EUR 1. Non-current tangible assets are depreciated over 3-6 years of useful period.

Foreign Currency

All currency items in the balance sheet are presented in euro, applying the currency exchange rate effective as at the balance sheet date. Differences arising upon the payment of amounts recognized in foreign currency items at another exchange rate are recognized as income or costs of the reporting period.

Current Assets

• Prepayments. Prepayments to suppliers for inventories or services that the Institution will receive later on.

Accounting of Funding

Sources of funding received by the Institution are following:

- Subsides;
- targeted contributions;
- other.

Subsidies are recognized when the non-current assets are received free of charge or acquired using funds allocated to the program. Subsidies are recognized and shown in the balance sheet when they have the following characteristics:

- purpose of assets received corresponds the objectives set out in the statute on an entity;
- the Institution receives non-current assets free of charge or acquires such assets for funds allocated to a program.

Accounting of subsidies is based on the accrual method. Subsidies are recognized as used when assets received free of charge and acquired for targeted funds are depreciated. The unused part of subsidy is shown in the balance sheet. The Institution collects information specified by givers, group of assets received.

Targeted contributions include support from international support funds to achieve defined objectives Targeted contributions are recognized and booked if they meet the following criteria:

• the nature of activity established in the statute of the receiver of contributions corresponds the requirements set for funding;

- there are decision confirmed by documents and other evidence that contributions will be received;
- Institution has incurred expenses, financing to which is arranged.

If the targeted contributions meet the criteria set out in the definition, they are recorded as receivable. If the target contributions do not meet the recognition criteria, they are recorded in the accounts as target contributions received after their actual receipt. Examples of targeted contributions may include support for the achievement of the objectives set out in the cost estimate, support for the organization of funding the event.

Targeted contributions are recognized as used to the extent that expenses incurred are recognized as to be compensated. After use of targeted contributions for acquisition on non-current assets, only the item of funding changes: the subsidy increase, targeted funding decreases.

The Institution may receive funding other than subsidies, targeted contributions. An example of such funding may be supply of goods, when the giver sets out a purpose of use, donations or other type of funding, when the giver does nor specify a particular purpose of use.

Funding received for a specified or unspecified purpose is recognized as used in the same manner as targeted contributions. Funding is goods is carries at fair value and booked as stock. Such funding is recognized as used (expenditure is recognized as compensated) during the period in which stocks received are used.

The value of support in services (including voluntary work) is estimated at the amount an entity have to pay if services were purchased, Support in services free of charge is determined by reference to the assets' fair value.

Acquisition costs of assets received free of charge is determined by reference to the assets' fail value.

Liabilities

Liabilities of the Institution are recognized and stated in the balance sheet when the Institution undertakes obligations which shall be fulfilled. Liabilities are carried at cost.

Operating Expenses

Expenses are recognized on an accrual and comparative basis in the reporting period when they are incurred. Operating expenses include the following: maintenance of premises, communications, postal services, remunerations, depreciation, business trips, consultants, organising conferences and other.

Transferred funding includes money means transferred to sub-recipients. In all such Institution is fully responsible to the donor, at the same time sub-recipients are fully responsible to the Institution for usage of funds transferred.

In 2017 the Association was founded by three founders: Leonid Vlasenko, Agita Seja and Lyudmila Trukhan, who have also become members of the association since its registration in the Register of Legal Entities. According to the Articles of Association, the annual financial report of the Association is approved by the General Meeting of the Association. In 2017 December 31 the number of members was 185, and in 2018 December 31 the number of members increased to 251 members, in 2019. December 31 the number of members is 265, in 2020 December 31 the number of members is 312.

MISSION AND OBJECTIVES

Eurasian Harm Reduction Association (EHRA) is a non-for-profit public membership-based organization uniting harm reduction activists and organisations from Central and Eastern Europe and Central Asia (CEECA) with its **mission** to actively unite and support communities and civil societies to ensure the rights and freedoms, health, and well-being of people who use psychoactive substances in the CEECA region. The Association is registered in Lithuania in 2017 continuing regional harm reduction activists' network tradition since 1997.

The EHRA's vision is to have an active movement in each CEECA country that advocates for human policies and access to evidence-based and needs-based harm reduction services for people who use psychoactive substances.

EHRA's activities 2020 were driven by the newly developed long-term <u>Strategy 2020-2024</u>, which gives emphasis to key areas of advocacy work: for legal regulations aimed at decriminalization, depenalization, and protection of the rights of people who use psychoactive substances; for access to high-quality, evidence-based, gender-transformative, non-discriminatory harm reduction services and to ensure sustainability of harm reduction services as part of the transition from donor support to national funding.

45 new organizations and activists joined EHRA in 2020, counting 312 organizational and individual members by December 31, 2020.

EXECUTIVE SUMMARY OF 2020 RESULTS

COVID-19 global crisis, geopolitical conflicts, and negative developments in political landscape in countries of EECA have been threatening sustainability of harm reduction programs and put people who use drugs at risk of deeper poverty and marginalization in 2020. EHRA have taken a number of actions in response to that challenges and COVID-19 crisis by expressing its position on the importance of continuity of harm reduction services, collecting and presenting data on state of harm reduction, helping organizations in country to document and report challenges with harm reduction service provision, supporting services particularly to protect women who use drugs from gender-based violence.

In 2020 EHRA implemented 13 regional projects funded by the Global Fund, Robert Carr Fund, Elton John AIDS Foundation, Open Society Foundations, European Commission, UNAIDS, Global Challenges Research Fund and other donors.

COVID-19 related travel restrictive measures have had a significant impact on the program activities of EHRA, especially with regard to face-to-face events. Some of the events we were forced to reprogram into a virtual format. Nevertheless, the year 2020 was rich in various thematic advocacy and capacity building meetings and events (see *chart below*). In 2020, on its own we organized 17 regional and country events and another 11 events in collaboration with partners. We took active participation in 32 virtual and 21 face-to-face forums delivered in 2020 by international and regional partner organization to share our expertise and promote EHRA strategic messages.




CHART: Types of events where EHRA took part in 2020.

In 2020 we provided 27 sub-grants to support community advocacy on national and local level in 12 CEECA countries each going with technical support from regional level. This includes grants for advocacy on "new" harm reduction services (Serbia, Lithuania, Kazakhstan, Croatia); grants to conduct national campaigns "Chase the virus, not people!" in Armenia, Estonia, Kazakhstan, Montenegro, grant for community-led monitoring in Georgia and grants to analyse national budgets for health and social services for key populations in Armenia, Bulgaria, Romania, Ukraine and Kyrgyzstan.

In 2020, we developed and published more than 20 publications including three regional reviews, two reports on legal analyses, two research methodologies, 11 research reports, one research article and one case study collection.ⁱ

- To validate the effectivity of cooperation practices in outreach work, through case studies at local level;
- To advocate for the upscaling of evidence-based cooperating practices in outreach interventions, especially the integration of PE. The active participation of different key-actors will promote the upscaling of European heritage and the advocacy function of CSO;

- to produce online videos on selected drug-related issues to educate young people, peers and the public about drug-related risks and harms and effective ways to reduce them;

- to provide 3 series of training courses for the participants of the project, based on the "Manual on Drug Education" and equip participants with new knowledge on drug education in youth work;

- to share and discuss project outputs and build partnerships among different stakeholders on national level, through organizing 5 multiplier events in the project countries;

- to disseminate project outputs on national, European and regional levels.

12. OVERCOMING LEGAL BARRIERS FOR KEY POPULATIONS - ON THE WAY TO 90-90-90

Target Countries and territories: Georgia, Kazakhstan, Moldova and regional activities

Aim / Objectives:

The project aim is to improve the effectiveness of HIV continuum of care by overcoming legal barriers for the most vulnerable key populations on the EECA city level.

Objective 1: To build capacity of paralegals and supporting legal experts in selected EECA cities to address legal barriers in the access of key populations to HIV continuum of care.

Objective 2: To provide legal assistance to people from vulnerable populations to overcome legal barriers to get access to HIV continuum of care.

Objective 3: To address cases of systemic legal barriers to decrease stigma, discrimination and criminalization and ultimately to decrease vulnerability of key populations to HIV and improve their access to HIV continuum of care.

- ✓ Project Monitoring, evaluation and learning plan and framework was developed;
- Expert partner agreements with HIV Legal Network, ECOM Eurasian Coalition on Health, Rights, Gender and Sexual Diversity and Sex Workers' Rights Advocacy Network (SWAN) were signed;

13. ACCESS TO COMPREHENSIVE CARE FOR WOMEN USING DRUGS IN CASE OF VIOLENCE

Granted by the Alliance for public health under project funded by the Global Fund to Fight AIDS, Tuberculosis and Malaria (GF)

Duration: Nov. 2020 – Jun. 2021

Budget: 73.119,00 USD

Project Status: in progress

Target Countries and territories: Belarus, Bosnia and Herzegovina, Georgia, Kazakhstan, Kyrgyzstan, Macedonia, Moldova, Montenegro, Romania, Russia, Serbia, Tajikistan, Ukraine, Uzbekistan

Aim / Objectives:

Build or strengthen partnerships on the local and national level between HR services and shelters, psychosocial (including psychiatry) and legal counsel service providers to ensure that health and human rights of WUD who experience violence are protected in the time of COVID-19.

- Develop recommendations on referring WUD the victims of violence and human rights violations, for getting legal and psychosocial (including psychiatric) support and temporary shelter.

- Carry out a two-day on-line training for HR service organizations on building systems of referral to provide psychosocial (including psychiatric) support, shelter and legal counsel to WUD experiencing violence and human rights violations.

- Provide 5 small grants to NGOs in 5 countries on building systems of referring WUD experiencing violence and human rights violations to shelters, legal and psychosocial (including psychiatric) support within HR projects.

- Share experience regionally on best practices referring WUD experiencing violence and human rights violations to shelters, legal and psychiatric support.

- ✓ The Expert Group formed to help EHRA throughout implementation of the project: advise on the text of Recommendations, provide information on access to services for women using drugs experiencing violence in their countries and the region. The Expert Group consists of 8 members from Georgia, Kazakhstan, Kyrgyzstan, Lithuania/EHRA, Moldova, Russia and Ukraine.
- ✓ The online training "Organizing support to women using drugs in case of violence" was held on 10, 11 and 14 December 2020 in English and Russian. Participants (18) came from Georgia, Kazakhstan, Kyrgyzstan, Moldova, The Netherlands, Serbia, Slovakia, Russia and

Ukraine. The experience with the training topic of the participants ranged from extensive (e.g. Kyrgyzstan) to minimal (e.g. Serbia).

- The most relevant topics of the training for participants were: services for women using drugs experiencing violence and types of violence; analysis of partners in provision of services; analysis of the needs of women experiencing violence, existing services and level of access to services for women using drugs; security issues of women using drugs experiencing violence when they turn to services and of staff providing services in case of violence.
