





## Our response to COVID-19 crisis





- Together with "CORRELATION" European Harm Reduction Network (EHRN) the joint **position** on the importance of continuity of harm reduction services during the **COVID-19** crisis was formulated and widely disseminated.
- The **COVID-19 alert system** of the EECA (Eastern Europe and Central Asia) Regional Platform has been launched to identify risks, problems, disruptions, opportunities and innovations that affect the implementation of programs supported by the Global Fund in countries.

- An **overview** of harm reduction programs in 22 CEECA countries during the **COVID-19** crisis was prepared with the support of the SC (Steering Committee) and active participation of 51 EHRA members from 22 countries in the region.
- We have launched a project to protect women who use drugs from gender-based/intimate partner violence and human rights violations during the **COVID-19** crisis.


Together with international partners, we prepared a **letter** to the Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health on the protection and promotion of the health of people who use drugs during the **COVID-19** emergency.

Develop and support national movements of allies advocating for legal regulations aimed at decriminalization, depenalization, and protection of the rights of people who use psychoactive substances





Prepared a **review** of **legislative initiatives on the liability of drugrelated advocacy** (so called propaganda) in Kazakhstan, Russia and Ukraine. The review analyzes possible risks to social programs aimed at working with people who use drugs.


Analyzed the *proportionality of fines for drug possession* in the Kyrgyz Republic.

Carefully selected *11 arguments* for advocacy *in favor* of evidence-based, health and human rights-oriented *approaches instead of criminalization* and published them as a **pocket guide**. Prepared and conducted an **online course** on **gathering evidence on human rights violations** for Southeast Europe.

Together with the EHRN, "Correlation" organized **sessions** on *different approaches to decriminalization* (initiated to replace the 5<sup>th</sup> European Conference on Harm Reduction).

The training course for **para-legals** was developed in cooperation with partners (in Russian).

# Human Rights Protection



Legal **analysis** on human rights violations against women who use drugs in Russia was developed.

Together with the Canadian HIV/AIDS Legal Network and the All-Ukrainian Association of People Living with Drug Addiction WOLNA the **report** to the UN Committee on Economic, Cultural and Social Rights on the proportionality of punishment for people who use drugs and access to health and social services in Ukraine **was prepared** and submitted.

Together with Russian partners, two reports and a complaint about Russia to the UN treaty bodies were submitted:

- a report for inclusion in the List of Issues to the State in connection with the consideration of the 8<sup>th</sup> Periodic Report of the Russian Federation at the 129<sup>th</sup> session of the International Covenant on Civil and Political Rights;
- a **report** to the UN Committee on the Elimination of All Forms of Discrimination against Women (CEDAW);
- complaint to the UN Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health and to the UN Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression.













We developed a comprehensive **report** on the state of harm reduction in Eurasia, which became part of the Global State of Harm Reduction Report, which is issued by HRI (Harm Reduction International) every 2 years.







**Conducted assessment** of situation with *drug education* in 5 countires: Bulgaria, Hungary, Lithuania, Poland and Serbia. The manual will provide an innovative, attractive, and effective way to inform young people about drugs and risks of using them.

Produced a series of videos on introducing **new approaches to harm reduction** in the CEECA (Central and Eastern Europe and Central Asia) region. All **videos** are available in English with Russian subtitles.

Published the **results** of a pilot study **on client satisfaction with Opioid substitution therapy (OST)** programs in Ukraine. The study was conducted in close partnership with the community of people who use drugs.



**Strategic** 

Conducted a discussion forum and training for "peers" to strengthen the involvement of "peers" in the provision of harm reduction services in Lithuania.

- Supported a training event for **peer** consultants and social workers in Kyrgyzstan.
- Performed a field visit and provided harm reduction services at music festival in Lithuania.

Promoted access to comprehensive support for women who use drugs experiencing gender-based violence:

- Conducted a **two-dav** online training for female professionals and activists on organizing comprehensive support for women who use drugs experiencing genderbased/intimate partner violence and human rights violations:
- Supported small grants in 5 countries of the region (Kazakhstan, Moldova, Northern Macedonia, Russia, Serbia) to organize assistance and provide shelter, psychiatric and legal counselling to women in situations of violence:
- Developing methodological recommendations for specialists.

Supported the introduction of innovative harm reduction services in countries:

- **Croatia** drug consumption;
- Kazakhstan online peer counselling;
- Lithuania and Serbia drug checking.

Published *research* results on new psychoactive substances (NPS) in Georgia, Kazakhstan, Kyrgyzstan and Serbia in partnership with Swansea University's School of Law.

Conducted national discussions on the results of research on NPS in Kazakhstan, Kyrgyzstan, and Serbia, and on further steps to adapt harm reduction package for NPS users.

Developed an academic paper on NPS, accepted for publication in peer-reviewed Harm Reduction Journal.

Ensure sustainability of harm reduction services as part of the transition from donor support to national funding





Developed a **methodology** to assess the **sustainability of opioid agonist therapy (OAT) programs** in the context of the transition from donor support to national funding.

Conducted an **assessment** of the sustainability of the OAT programs in Belarus, Moldova, Tajikistan and Ukraine. Results of the assessment were discussed with national stakeholders online. Developed an <u>online</u> toolkit on budget advocacy.

> Organized a **regional 3-day meeting of partners** to summarize the results **of budget advocacy** in the region in recent years.

Finalized a methodology for evaluating the implementation of transition plans from donor funding to state funding. Advocated for inclusion of harm reduction funding in EECA in the GF Strategy and the **UNAIDS Strategy.**




