From there, there are buses going to different places in Poland, as well as volunteer drivers offering rides in their cars. PKP Intercity allows Ukrainian citizens to travel by train free of charge on the basis of a document confirming citizenship. Free tickets with a seat reservation for Ukrainian citizens must be collected at ticket offices at railway stations. To be included in the substitution treatment people need PESEL number. If the person has medical records of treatment in Ukraine - the treatment can be implemented right away. However, having documentation is not a prerequisite for entering therapy. An appointment with psychiatrist has to be scheduled in advance.

Some programs have a limited number of places and queue (waiting time several months). This applies to programs in Poznan, Zielona Gora and Kostrzyn.
